સંખેડા,૨૨ સંખેડા તાલુકાના સનોલી ગામમાં ગાયોના થતા મોતના કારણે ગામના રહિશો, પશુપાલકો પરેશાન થઈ ઉઠ્યા છે. સનોલીના સરપંચ જેંતીભાઈ એ જણાવ્યું હતું કે, ‘અગાઉ પણ ગાયોના મોત થયા અને આ અકબાીયામાં પણ ગાયોના મોત થઈ રહ્યા છે. સનોલી ગામ અને વસાહતમાં ગાયોના મોત થયા બાદ ગતા અઠવાડીયે પશુ ચિકિત્સક અહિયા આવ્યા હતા. અને હડકવા પ્રતિરોધક રસી પણ મુકાઈ હતી. પણ તે બાદ પણ ગાયોના મરવાનો સીલસીલો બંધ થયો નથી. ગાયો મરવા પાછળ હડકવા હોવાનું કહેવાય છે.

હડકવાની રસી મુકાયા બાદ પણ ગાય મરી છે. સંખેડા તાલુકાના સનોલી ગામે એક જ દિવસમાં બે ગાયોના મોત સાથે છેલ્લા ૭ જેટલી ગાયોના મોત થયા. છેલ્લા ૧૫ દિવસથી આ ગામમાં ગાયોના મોતનો સિલસિલો ચાલી રહ્યો છે. જેના કારણે ગ્રામજનો પણ પરેશાન બન્યા છે. પશુ ચિકિત્સકના જણાવ્યા મુજબ હડકવાના કારણે

સાવલી તા.૨૨ સાવલી તાલુકામાં ખાખરીયા નર્મદા કેનાલ પાસે મિત્ર સાથે ફરવા આવેલી સગીરાને સાવલી પોલીસ મથકના ત્રણ જીઆરડી જવાનો અર્ને તેના મિત્ર મળી કુલ ચાર જણાએ ૧૬ વર્ષિય સગીરાને રોકિંગના બહાને રોકીને ધમકાવી, રૂપિયા પડાવી લાવા તેમજ ચારમાંથી એક જીઆરડી જવાન અનિલ ગોહિલે યુવતી પર દુષ્કર્મ આચર્યાના બનાવમાં મુખ્ય આરોપીને પણ ઝડપી પાડવામાં આવ્યો છે.

વાઘોડિયા તાલુકાથી યુવક અને યુવતી ખાખરીયા કેનાલ પર ફરવા માટે આવીને બંને બાઈક પર બેઠાં હતાં એ સમયે જીઆરડી અનિલ ગોહિલ અને તેના મિત્ર સંઘર્ષ પટેલે ત્યાં આવી પોતે પોલીસ હોવાની ખોટી માહિતી આપી યુવક અને યુવતીને ધમકાવવાનું શરૂ કર્યું હતું. યુવક અને યુવતીના માતાપિતાને બોલાવવા પડશે એમ જણાવી બ્લેકમેલ કરી પતાવટ કરવી હશે તો રૂપિયા આપવા પડશે તેમ કહ્યું હતું. એ જ સમયે આરોપીઓના બીજા બે મિત્ર જ્યેન્દ્ર સોમસિંહ ગોહિલ(૨૯).રાણીપુરા તા. સાવલી) અને મહેશ બાલુભાઈ

ગાયો મરી છે. પણ જે ગાયોને હડકવાની રસી અપાઈ હતી તેના પણ મૃત્યુ થયા હતા. ગાયોના મોત પાછળનું સાચુ કારણ શું? એ જાણવા પોસ્ટમોર્ટમ પણ થાય એ જરુરી બન્યું છે. તા.૧૩ ઓગસ્ટ પછી બીજી પાંચ-છ જેટલી ગાયોના મૃત્યુ થયા છે.

હજી ગામમાં આવા લક્ષણ ધરાવતી બીજી ત્રણ-ચાર જેટલી ગાયો છે. જેમને અન્ય ગાયોથી દૂર બાંધવામાં આવી છે.’જોકે અત્રે ગાયોના થઈ રહેલા શંકાસ્પદ મોત બાદ વેટરનરી ડોક્ટર પણ અહિયા દોડી આવ્યા હતા. અને જે ઘરે હડકવાના લક્ષણો ધરાવતી ગાયો હતી. તેમના ઘરે અન્ય ગાયોને રસી મુકવાની કામગીરી પણ કરી હતી. જો આવી રીતે ગાયોના મૃત્યુનો સીલ્સીલો ચાલુ રહે તો ગૌવંશ આ વસાહતમાં પૂરો થઈ જાય એવી દહેશત ફેલાઈ છે. સત્વરે આ બાબતે ઉંડાણ પૂર્વકની તપાસ કરીને ગાયોના મૃત્યુ પાછળનું સાચુ કારણ શોધાય અને આ સીલસીલો અટકે એવી કાર્યવાહી કરવા પણ માંગ ઉઠી રહી છે.

ગ્રામ્ય ટ્રાફિક શાખામાં ફરજ બજાવતા તાશ પી.જે.ખરશાણ તથા બિજા ટ્રાફિક નો પોલીસ સ્ટાફ સ્થળ ઉપર આવી પહોંચતા નકલી પોલીસ નો પદફાંશ થયો હતો.સાચી પોલીસે ત્રણેની પુછપછ કરતા (૧)મિતુલ અશોક રોડીયા..,રહે.વિજય સોસાયટી આર.વી.દેસાઈ રોડ વડોદરા.. (૨)વિનિત નીતિન ભાઈ શાહ..રહે.લાલબાગ સોસાયટી બેંક ઓફ ઈન્ડિયા સામે માંબલપુર વોદરા..
