હડકવાની રસી મુકાયા બાદ પણ ગાય મરી છે. સંખેડા તાલુકાના સનોલી ગામે એક જ દિવસમાં બે ગાયોના મોત સાથે છેલ્લા ૭ જેટલી ગાયોના મોત થયા. છેલ્લા ૧૫ દિવસથી આ ગામમાં ગાયોના મોતનો સિલસિલો ચાલી રહ્યો છે. જેના કારણે ગ્રામજનો પણ પરેશાન બન્યા છે. પશુ ચિકિત્સકના જણાવ્યા મુજબ હડકવાના કારણે

સંખેડા,૨૨ ગાયો મરી છે. પણ જે ગાયોને હડકવાની રસી અપાઇ હતી તેના પણ મૃત્યુ થયા હતા. ગાયોના મોત પાછળનું સાચુ કારણ શું? એ જાણવા પોસ્ટમોર્ટમ પણ થાય એ જરુરી બન્યું છે. તા.૧૩ ઓગસ્ટ પછી બીજી પાંચ-છ જેટલી ગાયોના મૃત્યુ થયા છે.
